1. Mudane Maxamed C/kariim Ibraahin:

Wuxuu haystaa Shahaadada Darajada Kowaad (Bachelor of accounting) oo uu ka qaatay Jaamacadda SIMAD sanadkii 2010 iyo Shahaadooyin kale oo Dibloomooyin ah sida; Kumpuyuutarka, hababka maareynta xisaabaadka iyo loogistikada. Wuxuu sidoo kale soo qaatay tababaro aad u kala duwan oo isugu jira dhaqaalaha, hab-qoraalka iyo barnaamijta shaqo raadinta. 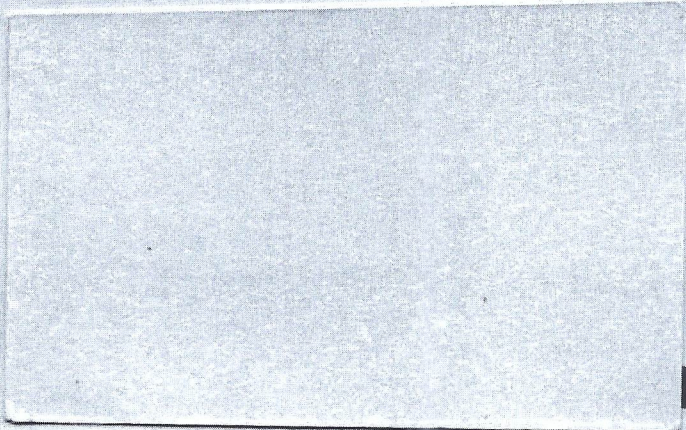

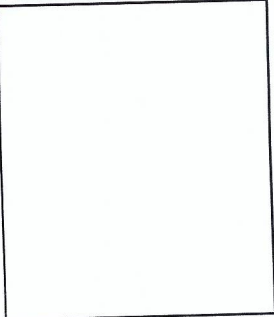
